# REGULATION REGARDING THE SIGNS AND SYMBOLS OF THE GEORGE EMIL PALADE UNIVERSITY OF MEDICINE, PHARMACY, SCIENCE, AND TECHNOLOGY OF TÂRGU MUREȘ

**Art. 1.** The present regulation establishes the University's own signs and symbols, as well as the way they are used.

**Art. 2.** The University's own signs and symbols are the following:

- a. The flag of the University and the flags of the faculties
- b. The emblem of the University and the emblems of each faculty
- c. The colours specific to the faculties
- d. The seal
- e. The formal attire

#### **I. The flag of the University and the flags of the faculties**

**Art. 3.** The flag of the university - has a format of 2/3 and includes three equal horizontal stripes having the colours: blue-white-blue, on which the University emblem is centred.

**Art. 4.** The flag of the University is flown:

- a. Permanently: on the main buildings of the University (at the rector's and the faculties' headquarters), together with the Romanian flag and the EU flag; inside the main administrative headquarters: in the rector's and the deans' headquarters (together with the flag of the faculty), in the senate hall and in the halls for official meetings; for special situations (official conversations), the flag pennant can also be used.
- b. Occasionally: for university ceremonies and public activities, other than teaching, organized with the support of the University.

**Art. 5.** The flag of each faculty - has a 2/3 format, unique colour, corresponding to each faculty, on which the faculty emblem is centred.

**Art. 6.** The flag of the faculty is flown:

- a. Permanently - at the faculty headquarters, together with the University flag, the Romanian flag and the EU flag; at the main administrative headquarters: at the deans' headquarters.
- b. Occasionally: on the occasion of university or faculty ceremonies and public activities, other than teaching, organized with the support of the University / Faculty.



## II. University emblem

**Art. 7.** The emblem of the university - has the circle as a basic form of visual identity and inside it, the official name of the University is inserted circularly. The following graphic elements are included inside:

- a. The sun - in the upper area - as a sign of wisdom - the sun's rays directed downwards represent the information that is spread from the main core; the sun - signifies the transfer of information and knowledge and symbolizes the connection between professors / teachers and university students.
- b. The eagle - in the middle area - the eagle taken from the coat of arms of Transylvania - as a symbol of power, prestige and self-knowledge.
- c. The open book - in the lower area - the book represents the moment of acquiring information, competences, qualifying for a specialization - this symbol is used as a support for the representative elements of each faculty.
- d. 1945 - the year when the University was established.

**Art. 8.** The emblems of each faculty follow the emblem of the University in terms of shape and design, preserving the symbols common to the university: the sun, the eagle, the book and the year 1945. The official name of the faculty will be included in the upper half of the circle. In the lower half, the abbreviated form of the name of the University will be included. Specifically, for each faculty, the following symbols will be superimposed on the open book:

- a. Faculty of Medicine - medical caduceus
- b. Faculty of Medicine in English - medical caduceus superimposed over the globe
- c. Faculty of Dentistry - dental caduceus
- d. Faculty of Pharmacy – Hygeia bowl with Aesculapius snake
- e. Faculty of Engineering and Information Technology - cogwheel
- f. “Petru Maior” Faculty of Sciences and Letters - quill superimposed on the open book
- g. Faculty of Economics and Law – the scales of justice and a chart

## III. Colours specific to faculties

**Art. 9.** The specific colours of each faculty are:

- a. Faculty of Medicine - royal blue
- b. Faculty of Medicine in English - peacock blue
- c. Faculty of Dentistry - light blue



- d. Faculty of Pharmacy - violet blue
- e. Faculty of Engineering and Information Technology - kelly green
- f. “Petru Maior” Faculty of Sciences and Letters - yellow
- g. Faculty of Economics and Law - orange

**Art. 10.** The specific colours of each faculty will be part of their visual identity and will be promoted both in the current activities and in the official online environment.

#### IV. University Seal

**Art. 11.** The seal of the University - is the imprint of the University on official documents, other than those with implicit legal value - contains the embossed and mirror image of the University emblem.

#### V. Formal attire

**Art. 12.** The ceremonial attire consists of:

- a. Robe - black colour, anterior vertical insertion, according to the colour of each faculty; braid on sleeves: 1 braid for vice-deans, 2 braids for deans, 3 braids for vice-rectors and the senate president, 4 braids for the rector. The braids for deans and vice-deans in the colour of each faculty; the braids for vice-rectors in navy blue; the braids for the rector in Bordeaux red; the robe will have embroidered on the left side the emblem of the faculty (deans, vice-deans) or of the university (rector, vice-rectors, president of the senate);
- b. Cap - black colour, with a golden tassel;
- c. Ceremony collar - worn by the rector and engraved with the university emblem as a medallion, the emblems of each faculty on medallions inserted in the chain of the collar, the name of each rector of the university on a banner inserted in the chain - the collar is transferable to each rector;
- d. For students - the specific scarf of the study program. Each faculty will establish, for the graduation ceremonies, the specific colours of each study program; they will be unique. The graduation cap has the symbol of the graduates' Faculty.

**Art. 13.** The ceremonial attire for the personalities who are awarded the title of Doctor Honoris Causa of the University has the same characteristics: the robe with no braids on the sleeve and with the vertical stripe in purple; and the black cap.

**Art. 14.** The ceremonial attire is worn on the following occasions:

- a. The closing ceremony of the academic year
- b. Opening ceremony of the academic year
- c. The awarding ceremony of the title of Doctor Honoris Causa

d. Participation in similar ceremonies of other universities, if the local protocol allows it.

**Art. 15.** The use of the signs and symbols of the University is made strictly under the conditions mentioned above, their modifications or adaptations not being allowed.

*The Senate of the George Emil Palade University of Medicine, Pharmacy, Science and Technology of Târgu Mureș approved the present regulation following the online vote held between July 5 - July 8, 2019, validated the result of the online vote on July 25, 2019 and this regulation gets into force on September 23, 2019.*
