



THE ROUTE OF STUDENTS AND PATIENTS IN THE INTEGRATED DENTAL CENTER FOR THE PERIOD OF TRANSMISSION RISK OF SARS-CoV-2 VIRUS INFECTION

In accordance with the *Plan of measures regarding the teaching and learning activities in the context of the COVID-19 pandemic* approved by the Senate of “G.E. Palade” UMPHST from Tg. Mureș on September 3, 2020, especially the specifications regarding the *dental internships of the students from the Faculty of Dentistry*, **the route of students and patients in CIMD will be as follows:**

GENERAL MEASURES

- Inside the Integrated Dental Centre (CIMD), **wearing a face mask is mandatory;**
- All the persons who enter the CIMD will have their temperature recorded by an auxiliary or non-teaching staff of the Faculty of Dentistry;
- Upon entering the CIMD, hands will be disinfected with the sanitizer provided in special containers;
- All the students and patients who enter the CIMD will fill in **the Epidemiological Triage Questionnaire:** https://www.umfst.ro/fileadmin/materiale/download/Chestionar_pentru_triaj_epidemiologic.pdf

1. STUDENT ACCESS TO CIMD CLINICAL COMPARTMENTS

- **Access to CIMD is through the main left door**, keeping the minimum distance required, in order to avoid congestion;
- In all 4 clinical compartments, students can enter through the hall behind the clinics, through the locker rooms; access is allowed for 2 small groups of students/compartment;
- In the locker rooms, in order to avoid congestion, the access of a maximum of 5 students is allowed; the rest of the students will wait in the hallway, keeping the required social distance; they will have access to the locker room once it has been vacated;
- In the clinical compartments of CIMD, all students will wear healthcare uniform – scrub trousers and tops, face mask, medical shoes;
- The uniform used in the clinical compartments will not be worn in the access hall to the clinics;
- It is not allowed to pass through the adult reception area and amphitheatres with protective equipment;
- **Exit from the clinics will be through the door of the Children's Registry.**

2. STUDENT ACCESS TO ROOM P21 (for practical anaesthesiology lessons)

- Access is allowed for a small group of students;
- Students will wear medical uniforms – scrub trousers and tops, face mask, medical shoes; they can put them on in the locker room located next to room P21;
- After finishing the lessons, students will leave room P21 at intervals (avoiding congestion) and CIMD on the right front door.

3. STUDENT ACCESS TO ROOMS P38 AND P42 (according to the Regulation of the Discipline of tooth and dental arch morphology)

- The students' access is through the middle door of the C14 building;



- The students will leave the laboratories through the left door of the building (near the laboratory of dental technology), avoiding congestion and keeping the minimum social distance.
4. *STUDENT ACCESS TO ROOMS P31 AND P32 (THE SIMULATION COMPARTMENT)*
- The students can enter through the right door of the C14 building;
 - The students will leave the compartment through the same door, avoiding congestion and keeping the required social distance.
5. *STUDENT ACCESS TO AMPHITHEATRES/LECTURE HALLS FOR CBL/TBL ACTIVITIES*
- Upon entering the amphitheatres / lecture halls, students will keep the social distance, avoiding congestion;
 - Inside the amphitheatres / lecture halls, keeping the social distance is mandatory;
 - The students will leave the amphitheatres/lecture halls of the CIMD at intervals, avoiding congestion and keeping the mandatory social distance.
6. *WORKING CIRCUIT IN THE LABORATORY OF DENTAL TECHNOLOGY*
- All impressions / dental works will be thoroughly disinfected;
 - Their transport to the laboratory of dental technology will be done in plastic containers with lids, if possible at the end of the activity;
 - The transport containers will be thoroughly disinfected;
 - The prosthetic works sent from the laboratory of dental technology to the clinical compartments will be thoroughly disinfected before being tested / applied.
7. *PATIENT ACCESS TO CLINICAL COMPARTMENTS*
- **Patients' access to the CIMD will be through the door of the Children's Registry** where they are registered and where the files / documents will be issued, the epidemiological triage questionnaire will be filled in, and the temperature will be measured;
 - Patients' belongings can be stored in the locker room next to the Children's Reception;
 - **Patient access to the clinics** will be through the doors of the inner courtyard of the CIMD, except for the Preventive Dentistry Clinic, where patients can enter through the right intermediate door of the building;
 - It is not allowed for patients to pass through the access hall to clinics and the amphitheatre area;
 - After finishing the consultation / treatment, the patients will leave the treatment room through the same door they entered and will return to the Children's Registry with the completed treatment form to pay for the treatment.
